**TERMS & CONDITIONS**

1. Please be advised that the applicant may be subject to security vetting.
2. The applicant must be a Retired veteran who has served twenty-five (25) years or more with an honorable discharge.
3. The applicant is required to submit a valid police record and two recent passport photos at the time of the submission of this application to HMBS Coral Harbour Base, Head Quarters.
4. The approved applicant would be entitled to free access to **RBDF** facilities such as the Medical Facility for **basic** treatment, Commissary (for cash purchases only), Barber Shop, Gym, respective RBDF messes and any other amenities approved by the Commander Defence Force. However, all other RBDF facilities including crafts, armory, workshops, vehicles, and out-stations are out of bounds.
5. Entry to base would be subjected to the operational contingencies and at the Duty Officer's discretion.
6. Approved RVID cards will be dated to coincide with the birth month of the applicant for a maximum period of three (3) years. An additional three (3) years renewal may be applied for commencing three months prior to the expiration date of the RVID card.
7. All issued RVID cards are the property of the Bahamas Government (RBDF) and can be revoked at any time for any reason deemed by the competent authority and as such must be surrendered when required to do so.
8. An approved RVID card does not authorize the holder to enter into any binding agreement on behalf of the RBDF by any means whether verbal or written.
9. The RBDF assumes no criminal or civil liabilities, damages, or expenses incurred by the card holder. .
10. A valid RVID card does not confer to the holder the powers, duties and obligations of a serving member of the RBDF.
11. The main purpose of the RVID card is to identify the photographed holder as former member of the RBDF who has retired and has been honourably discharged after giving twenty-five (25) years or more of service to Country.
